Sl. No.	The school is directed to ensure that :
1	The total number of sections of the school shall be restricted to 15. Any further increase of section shall require prior approval of the Board, subject to compliance with affiliation bye laws and availability of rooms of 500 sq. ft. dimension.
2	School is not bounded with concrete boundary wall of 6 feet all around the school campus. Some part of the boundary wall has iron mesh, restricting the height of the concrete portion of the wall below 6 feet. The school shall remove the iron mesh and construct a concrete boundary wall of 6 ft height within 3 months and submit compliance on SARAS with videography.
3	Computer Lab is not sufficiently equipped. School has less number of computers as specified in SoPs issued by the Board vide Circular No.11 dated 04.10.2022. The School shall increase the number of computers to 40 and submit compliance on SARAS with videography.

4	The composite science lab is seen as under stocked. It does not have seating arrangement for students. Provision of gas connection & fire extinguishers has also not been made. 'Dos & Don'ts' chart has also not been displayed in the lab. The school shall upgraded the lab as per Board's SoP with proper gas connection in the workstations, storage facilities, seating arrangement and safety features such as fire extinguishers within 03 months and submit the compliance on SARAS with videography.
5	Mathematics lab appears to be a temporary set-up, which is under stocked. Proper seating arrangement has not been made in math lab. The school shall make proper seating arrangement, upgrade the lab as per SoP issued by the Board and submit the compliance within 3 months on SARAS with videography.
6	Library is seen as under stocked. The school needs to add more books of different genres, besides reference books, journals, magazines and newspapers. The school shall upgrade the Library in light of the SOP issued by the board and submit compliance within 3months on SARAS with videography.
7	One toilet is seen with a horizontal bar inside, which is in correctly placed and will not offer any support to CWSN. No grab bars on sides of WC are seen. No signage for CWSN toilet is seen. The school has converted a regular cubicle into CWSN toilets which are too small for a wheelchair/walker to enter and navigate, besides having raised entrance. CWSN toilets are not seen on every floor. The school shall construct separate toilets for CWSN, boys and girls on every floor with proper permanent signage, as per norms of RPwD Act and guidelines issued by the Board within 3months and submit compliance on SARAS with videography.
8	The school shall complete the installation of lift and make it functional within 3months and submit compliance on SARAS with videography.
9	The boys' urinals shown in the inspection video are without partitions. School shall make provision for partitions in the urinals within 3months and submit compliance on SARAS with videography.
10	The ramp at the entrance does not have hand rails. the school shall affix handrails along the ramp within 3months and submit compliance on SARAS with videography.
11	The school shall ensure the training of its teachers with CoE Panchkula within 3 months and submit the compliance.

Compliance of the above mentioned points shall be submitted, within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-

1. The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye -Laws-2018.
2. The school shall follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
3. The School shall apply online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.



5. The school shall renew mandatory certificates from time to time.
6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
7. Concerned Regional Office is requested to create new email id of school as per direction issued by controller of examination. This E Mail ID is used for communication with CBSE only.
8. The school shall not remove the documents and videography links in the mandatory disclosure section of its website.
9. The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated 04.10.2022.

If the compliance is not submitted within the stipulated 3 months, the Board may enhance the penalty amount and debar the schools from filling up registration/LOC details of students of classes IX to XII, as the case may be, in the next academic session i.e. 2024-25.
